



**BYLAW NO. 5/2025  
MUNICIPAL DISTRICT OF PEACE NO 135  
REVISED 2025 PROPERTY TAX BYLAW**

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE MUNICIPAL DISTRICT OF PEACE FOR THE 2025 TAXATION YEAR.

**WHEREAS**, the Municipal District of Peace No. 135 has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the council meeting held on April 30<sup>th</sup>, 2025 and

**WHEREAS**, the estimated municipal expenditures and transfers set out in the budget for the Municipal District of Peace No. 135 for 2025 total \$8 510,474 and:

**WHEREAS**, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$4,188,446.00 and the balance of \$4,322,028 is to be raised by general municipal property taxation; and

**WHEREAS**, the estimated amount required to repay principal debt to be raised by general municipal taxation is nil and;

**THEREFORE** the total amount to be raised by general municipal taxation is \$4,322,028 and;

**NOW THEREFORE** under the authority of the *Municipal Government Act*, the Council of the Municipal District of Peace no. 135, in the Province of Alberta, enacts as follows:

1. That the Interim Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Municipal District of Peace No. 135:

2. That the minimum amount payable per parcel as property tax for general municipal purposes shall be \$25.00.
3. This bylaw comes into force at the beginning of the day that it is passed unless otherwise provided for in the *MGA* or another enactment or in the bylaw. This bylaw is passed when it receives third reading and it is signed in accordance with S.213 of the *MGA*.

READ a first time on this 30<sup>th</sup> day of April, 2025.

READ a second time on this 30<sup>th</sup> day of April, 2025.

Given UNANIMOUS consent to go to third reading on this 30<sup>th</sup> day of April, 2025.

READ a third and final time on this 30<sup>th</sup> day of April, 2025
